CTS will adopt the five objectives defined by the Toronto Community Benefits Network (TCBN), namely: 1) Provide **equitable economic opportunities** that promote economic inclusion for all Toronto residents; 2) Contribute to the development of a system of **training and workforce development** programs that can enable economic inclusion; 3) Support **social enterprises** and other related vehicles to economic inclusion through commitments to **social procurement**; 4) Contribute to **neighborhood improvements** through building new transit infrastructure; and 5) Ensure **clear commitments and accountability** from all parties to deliver.

CTS is committed to working with the partners noted above to achieve a broader range of policy objectives. We will establish an agreement, and well-designed tools, policies and protocols to deliver on the objectives outlined here. It is our goal to ensure communities, residents, businesses, and industries within the Eglinton Corridor, including Priority Neighborhoods, will receive enhanced social and economic benefits from the Project.

#### **Equitable Economic Opportunities**

Develop specific targets and timetables for apprenticeship programs, supply chain contracts, design, construction and maintenance jobs, and ancillary positions

Establish liaison resources and protocols related to maximizing community benefits, including:

□ Working with local workforce agencies

Developing initiatives that enhance employment opportunities for local residents in the communities along the Eglinton Corridor

## **Training and Workforce Development**

□ Contribute and collaborate with TCBN for the establishment of a shared framework for workforce development

Develop subcontract procurement policies that will require a commitment to apprenticeships and job training

□ Work with sub-contractors and unions to improve opportunities for workers to be employed and gain the experience of a large infrastructure project, and establish hiring guidelines, development plans, and percentage targets for hours to be worked by the following:

Those residing in the disadvantaged communities along the Eglinton Corridor

□ Apprentices

Disadvantaged workers including unemployed youth; homeless; custodial single parents; veterans, and those lacking a high school diploma, and who have experienced chronic unemployment

□ Work with local colleges and high schools to highlight the opportunities in construction and maintenance of the ECLRT.

#### **Social Enterprises and Social Procurement**

Develop social procurement policies that foster the establishment and successful growth of social Enterprises

□ Refine existing initiatives to disseminate information about required goods and services that will give providers opportunities, work with community-based organizations to assemble a list of businesses within the Eglinton Corridor, and host Business Improvement Area associations

#### **Neighborhood Improvements**

□ Investigate ways to improve parkland in Priority Neighborhoods

□ Support resource centres for jobs, training, and social innovations at selected sites including the Kodak building at the Eglinton Maintenance and Storage Facility (EMSF)

□ Support the communities and community events including local fairs and events

Commit to resources required to deliver and monitor the CBA

Develop a quarterly monitoring report to demonstrate the ongoing progress and success of our community benefits program
